Dr Wendy Marsden

Dr Marsden is a Research Fellow at the ESRC Centre for Social and Economic Research on Innovation in Genomics (INNOGEN). She was a member of the legal and ethical team during the set up of Generation Scotland, and her research interests are at the interface between health, research, and innovations in science and technology.

Dr Alan McNair

Dr McNair is a Research Manager for Experimental and Translational Medicine within the Chief Scientist Office (CSO) of the Scottish Government. He is involved in implementing CSO's strategy which emphasises the translation of research for patient and population benefit. Part of his role is to manage the CSO's interaction with strategic health research initiatives for which it has provided funding, including Generation Scotland.

Professor David Jones

Prof. Jones is Director of the Anscombe Centre, established by the Catholic Bishops in 1977, which covers England, Wales, Scotland and Ireland. He is also Research Fellow in Bioethics at Blackfriars Hall, Oxford, and Vice Chair of the Ministry of Defence Research Ethics Committee. He was formerly Director of the Centre for Bioethics and Emerging Technologies at St Mary's University College, Twickenham, where he remains a Visiting Professor.

Dr Jean Turner MB ChB DA

Having qualified in Medicine at Aberdeen University in 1965, Dr Turner worked as an anaesthetist and General Practitioner for many years. She was then elected as an Independent Member of the Scottish Parliament for Strathkelvin and Bearsden from 2003-2007, and is now the Executive Director of Scotland Patients Association.

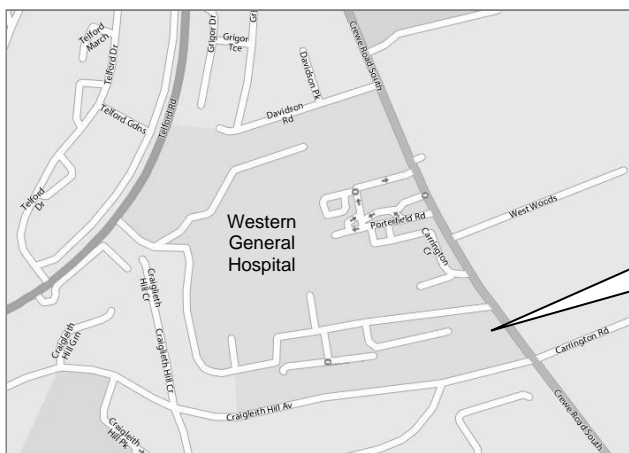
